3.1<u>Update from Housing</u>.

Deirdre Flannery, A/Administrative Officer, Helen Butler, Administrative Officer and Eoin Delaney, Executive Engineer, Housing Section were in attendance for this item. A Housing Services Report for the period 01/01/2025 to 28/02/2025 was circulated to the Members in advance of the Meeting and taken as read.

The Members raised the following queries: -

- Has there been any communication from the Department to increase the HAP limits or the threshold of €30,000 for social housing assistance. Thurles town is currently very poor for housing provision with the average rental price for a two-bed apartment at €1,500 per month. Lots of people who qualify for HAP cannot secure accommodation and others who are just above the income threshold of €30,000 fail to qualify for social housing assistance.
- When will the Cluid Housing Development at Dun Lia Thurles be complete.
- What is the update regarding the various retrofitting schemes in the district, in particular with regard to Tara Drive, Gortnahoe where there are issues with the air-to-water heating systems.
- Are TCC on course with regard to funding for Priority 1, 2 and 3 and who specifically is in charge of dealing with the housing grant allocations.
- What is the update regarding the development at Cuchulainn Road, Thurles.
- Is there any flexibility with the Choice Based Letting (CBL) system to allow a tenant to view/bid on houses with a greater number of bedrooms from what they are approved?

Replies to queries raised were as follows: -

- The limits for Social Housing Assistance are set at national level and TCC have no discretion in this regard. With regard to HAP, TCC do have the discretion to apply a 35% increase above the approved rent limits. There has been no communication from the Department regarding any change to the thresholds.
- It is likely that the Cluid Housing Development at Dun Lia, Thurles will come on stream at the end of 2025.
- Housing surveys in Thurles District under the energy retrofit scheme will be undertaken next September.
 It is intended to establish a maintenance scheme that will identify all of the issues with the heating systems at Tara Drive, Gortnahoe.
- The issue regarding the availability of funding to undertake works under Priority 1, 2 and 3 of the Housing Grant Allocation Scheme will be checked and reverted back to the District.
 Sharon McLoughney, Housing Section is dealing with the scheme.

- The housing development at Cuchulainn Road, Thurles, is progressing. The design is complete and it is anticipated that the scheme will proceed to Planning by mid-2025.
- Choice Based Letting (CBL) does not permit a tenant to view/bid on houses with a greater number of bedrooms from what they are approved. The issue will be reviewed by Housing Section to see if there is scope within the system to amend the current settings.

4.1 To formally approve draft Schedule of Municipal District Works 2025.

4.3 <u>District Engineer's Report</u>.

The Members raised the following issues:-

- What is the update regarding the CCTV in Thurles town.
- · Can anything be viewed from the CCTV in Littleton?
- Public lighting is necessary and should be provided on the footpath at Ardnacrusha out as far as Dew Valley Meats in Thurles which employs up to 400 people.
- Is there any way that the road improvement works required on Kickham Street, Thurles can proceed given that the design works are complete? There is currently no funding allocation from the TII to undertake the works.
- What is Thurles MD's allocation under the Local Improvement Scheme (LIS) following the grant to TCC of over €1 million under this scheme.
- Has the MD received any funding to date from the Department to deal with the roads that were damaged as a result of the bad weather, in particular, at road junctions.
- The double yellow lines at the Derheen, Thurles have completely faded and need to be reinstated.
- Can the vertical indicators, where they have been knocked over, be replaced and the white lining, where necessary, be applied.
- Who is liable for the costs of repairing the barrier at the junction of Liberty Square and Slievenamon Road, Thurles following damage from road vehicles.
 - The barriers have been damaged on both sides of the junction on several occasions and pedestrians continue to walk outside of the barriers.
- There is a damaged bollard in Roscrea town centre that requires attention.
- Can the pedestrian crossing on Main Street, Templemore be relocated back to where it was temporarily located as its current location is not safe?

Replies to queries raised were as follows:-

- J&N Security previously undertook a review of CCTV cameras in Thurles town; all cameras require upgrading. Prior to 2025 there was no budget available for CCTV but as there is now funding available, the MD will progress the upgrading of the CCTV by first seeking approval from the Garda Commissioner.
- J&N Security are currently preparing costs for the CCTV in Littleton.
- With regard to the provision of public lighting at Ardnacrusha, Thurles
 out as far as Dew Valley Meats, it is not in keeping with TCC policy to
 provide public lighting outside the 50kph speed zone.
- The MD will liaise with the Roads Capital Section, regarding the proposed road improvement works required on Kickham Street, Thurles.

- The MD will obtain the breakdown and allocation to Thurles MD of the Local Improvement Schemes (LIS) funding.
- The Department have stated that there is currently no funding available to deal with storm damaged roads.
- Works on implementing line markings, vertical indicators, signage and headless signs will all be a priority for the MD.
- The MD will pay for the costs of repairing the damaged barrier at the junction of Liberty Square and Slievenamon Road through the TII National Road Maintenance as there is no way of knowing who the offender is.
 - The barrier on the right-hand side heading towards Slievenamon Road has been damaged once since the upgrade works and the MD will make adjustments to this barrier. The other barrier has not been damaged since the Liberty Square upgrade works and therefore no adjustments will be made at this side.
- The damaged bollard in Roscrea town centre will be examined.
- The current location of the pedestrian crossing is the desire line from schools and the town park. A survey has been completed and results are currently being compiled before the MD revert back to the TII. The results of the survey may warrant an additional crossing but further analysis will be required for the TII.
