Minutes of the Monthly

The minutes of the monthly meeting held on the 23 March 2023 were adopted on the proposal of Clir. I. Goldsboro, seconded by Clir. K. O'Meara, and signed by the Cathaoirleach.

4.0. Consideration of Reports and Recommendations

Item 4.1.
Report of Environment & Climate Action

Directorate

A report of the Environment and Climate Action Directorate was circulated and taken as read.

With Messrs. M. Moroney and R. Boland in attendance, the Councillors' queries were addressed along with clarification of impending schemes. The National Spring Clean initiative supported by the Council each year, was commended by the councillors as was the impending remediation design for the landfill site at Connawarries, Carrick on Suir.

Further discussion ensued in relation to various matters such as action on derelict sites, grants for septic tanks, responsible dog ownership, campaigns around restricted dog breeds and the

ongoing issue of dog fouling. It was noted that since circulation of report, an operation was carried out in Carrick on Suir to remove horses in the vicinity of Knocknaconnery during the past week.

Mr. Moroney indicated that he was seeking funding to trial a roadside vacuum cleaner to operate alongside the sweeper as a further initiative in tackling litter along road verges and outlined the proposed introduction of deposit and return scheme for plastic bottles shortly to be introduced nationally.

Mr. B. Beck, A/Director conveyed his appreciation of the Environment Section for their action on derelict sites, which was a priority for the municipal district. Responding to Cllr. I. Goldsboro's query regarding plans to extend action on derelict sites to the wider district areas, where some properties were derelict for upwards of 30-40 years, he outlined the challenges addressing these matters in context of staffing resources and competing demands on same.

Item 4.2. District Engineer's Report:

SCHEDULE OF MUNICIPAL DISTRICT WORKS - APR 2023

Having considered the updated report circulated for April 2023, the A/District Engineer, Mr. D. Power and Mr. P. Farrell responded to matters arising as follows

Cllr. M. Fitzgerald:

- Questioned whether there was potential to extend footpaths recently completed under CLÁR programme,
- Acknowledging the challenge of remediating recent flooddamaged roads, he sought update on same.

Mr. Power confirmed that the contractor had extended footpaths at Drangan as far as possible with the available CLÁR funding and stated that he would examine if any flooding events mentioned were eligible for OPW funding and/or climate adaptation grant aid.

Cllr. I. Goldsboro:

- Queried whether €90,000 allocation to remediate Gullet Bridge was adequate.
- Expressed her thanks to crew for their work at Máiréad's Cross, and queried the sequencing of further works at Copper Cross, Ballynonty and Grangemockler.
- Referring to IPB funded footpaths, she requested that attention be given to Moyglass with a number of issues of concern.
- Sought update in relation to traffic calming measures requested for Killenaule.

Mr. Power in response, confirmed that the €90,000 budget for Gullet Bridge was adequate to allow for reopening of the road,

noting that a crew would be on site in the coming week. Thereafter, it was intended to move to Ballynonty and with a final account to be done, he would see what was remaining and could be progressed at that stage.

Referring to the request for ramps/raised table at Killenaule, the District Engineer stated that it was not intended to install same but that alternative measures would be examined. He emphasised that engineering measures were not a substitute for enforcement and stated that Garda operations were a vital part of the solution at this location.

Mr. P. Farrell, Executive Engineer added that rumble strips, cats' eyes, signage and lining were other measures for consideration in the context of the road category involved.

Referring to Copper Cross, he noted that there was not much scope to improve without first discussing with landowners and the matter warranted further investigation.

In relation to Moyglass, he stated that he would meet with Cllr. Goldsboro and investigate on the ground.

Cllr. K. O'Meara:

- Discussed the prioritisation of footpaths to be funded by IPB
- Sought update re Community Involvement Scheme [CIS]
- Suggested that in compiling a scheme to address drainage issues, houses which were flooded should be prioritised in any such plans.
- Sought update in relation to the Bridge at Kilvemnon
- Queried outcome of speed survey at Mullinahone and whether flashing lights/marking would be appropriate

Responding to these queries, the District Engineer stated that the list of IPB-funded footpaths arose from public liability claims and were prioritised accordingly. He anticipated that the CIS would open for applications in about August for funding in 2024.

Noting comments in relation to prioritisation of flood alleviation measures, he noted that such works would be funded under the Climate Adaptation budget.

Mr. Power confirmed that a procurement process was underway for works to Kilvemnon Bridge, and, referring to speed survey carried out at Mullinahone, the results clearly indicated that traffic was travelling at an average 10kph over the speed limit – i.e. 70kph in a 60kph speed zone. He intended to contact the Gardai in an effort to have a speed van placed at this location in order to address the matter. He indicated that a follow up survey would be arranged in support of same.

Cllr. D. Dunne:

Referred to quarterly meetings between roads engineers and Gardai with a view to investigating accidents

Mr. Liam Brett, Senior Engineer, Roads, clarified the policy around the provision of ramps and raised tables for local roads. The rationale for same as per Traffic Management Policy, was that every other solution must have been tried, tested and have failed.

With respect to regional roads, the national guidelines were drafted to take account of potential impact on heavy goods vehicles and emergency service vehicles.

Referring to driver behaviour, he reiterated that enforcement was the answer to the problem and that that was firmly within the remit of the Garda authorities noting that the local authorities did not have the toolkit to deal with speeding. He agreed that engineering remedies were entirely appropriate only when funding was available for landscaping, narrowing of carriageways and such measures.

Item 4.3. District Administrator's Report:

R.R.D.F. Update

The Meetings Administrator informed the meeting that the RRDF District Delivery Group convened each fortnight to progress the Carrick on Suir Regeneration Plan in order to meet each Decision Gate as required by the Department of Rural and Community Development. She provided the following update on progress in relation to this major project;

- Funding Agreement issued by the Department was now in place as of 17 April 2023.
- The design team Malachy Walsh & Partners had prepared tender stage documents for Phase 1 (Ormond Castle Park, Part of Castle Street leading to Ormond Castle, Strand Lane and Sean Healy Park)
- It was expected to go to tender in the following fortnight, leading on to the appointment of Phase 1 Contractor in July 2023.
- With the imminent purchase of the Old Post Office from An Post, a Design Team will be appointed to prepare detailed design and contract management for the Enterprise and Digital Hub at Main Street.

 The ongoing CCTV surveying of storm and foul sewers was progressing well and should be completed in the following fortnight.

Cathaoirleach Annual Awards 2023

The Meetings Administrator outlined provisions contained within the Tipperary County Council Civic Protocols 2023 providing guidance for all corporate activities carried out at civic, public and She referred to recent discussion with the official events. Cathaoirleach, wherein it was decided to establish the Carrick on Suir Municipal District Cathaoirleach Annual Awards 2023. Its objective was to recognise the achievements of groups, individuals and organisations who attained significant success at county or national level through their achievements in sporting, cultural, academic, scientific, political, creative, innovation or other areas. The protocol allowed each councillor to submit one nominee to the meetings administrator which in turn would be forwarded to the Corporate Policy Group for consideration and approval at their next meeting to be held on the 5th May 2023. She requested that councillors would submit their nominations along with the reason for same to helen.cahill@tipperarycoco.ie not later than close of business on Wednesday 3rd May 2023 in order that consideration may be given to same by the Corporate Policy Group. It is envisaged that the awards ceremony will be held in June at an appropriate venue and that the fixture would be an annual event.
