"In the interest of safety, that Carrick on Suir MD looks at the provision of a pedestrian crossing on the Clonmel Road out of Mullinahone, where the new footpath works were completed on the village side of the approach from Blackthorn Walk estate, and to amend the white line marking to a solid white line from the estate through to the village centre.

Many children from the estate have started walking to school since the provision of the new footpath and a number have flagged safety concerns with speed of traffic whilst attempting to cross to the footpath on the other side."
