4.1 Notice of Motion in the name of Councillor J Ryan NOM ld 3036

I am calling on this District Council to install a raised pedestrian crossing along the Lognafulla Road in Thurles between the Water Tower and the Borroway / Bohernamona Road junction. It would act as a way to slow down cars coming down the hill and also as a means of allowing pedestrians to safely cross an extremely busy and dangerous road.

Reply to NOM

This junction was identified by the MD as requiring safety measures following the submission of planning applications in the area which would substantially increase pedestrian and traffic volumes.

To address this the MD set aside 2025 Development Levy monies (€30,000 - Bohernamona Road Widening) and we are currently engaging with landowners in the area to progress an overall solution.

Subject to agreements and a Section 38, further Development Levies will be allocated in 2026 to deliver traffic and pedestrian safety measures in the area.
